70th Anniversary of the **1951 Refugee Convention** Commemorated

In commemoration of Human Rights Day and the 70th anniversary of the 1951 Refugee Convention, the UNHCR Office of the Chief of Mission in Pristina and the University of Pristina Faculty of Law organized the Pristina Talks, a legal forum on the 1951 Refugee Convention. Local authorities, legal institutions, international universities, UN agencies and civil society discussed the opportunities, gaps and challenges that arise in mixed migratory movements involving refugees, asylum seekers and irregular migrants. A photo exhibition honoured the late Madame Sadako Ogata, the first female UNHCR High Commissioner (1991 - 2000).

Capital Investment Facility Launched to Support Climate Smart Infrastructure

UN-Habitat launched the Capital Invest-ment Facility (CIF), giving all 38 Kosovo municipalities the chance to receive innovative financing for climate smart infrastructure that supports both a sustainable, inclusive environment and active inter-municipal and intercommunity cooperation.

Created in partnership with the Ministry of Local Government Administration, the Ministry of Environment, Spatial Planning and Infrastructure and the Sweden Embassy in Kosovo, the CIF will remain available through 2025. (Municipalities and civil society organizations are invited to apply by 28 February 2022.)

UNOPS and ILO Present a Training Strategy to the Labour Inspectorate

ILO presented the "Multiannual Training Strategy" during a workshop with the Labour Inspectorate, proposing training modules that reflect updates in occupational safety and health for labour inspectors as well as gender-specific modules to enhance knowledge of gender equality laws and policies, women's participation in the labour market, and gender differences in exposure to occupational risks and hazards. The project, funded by the Swedish International Development Cooperation Agency (SIDA) through the Embassy of Sweden in Pristina, is implemented by UNOPS Kosovo.

UNICEF and the EU Develop a Programme to Protect Vulnerable Children

Improving Cooperation and Decision-Making Processes around Asylum Claims

The Civil Rights Program Kosovo (CRP/K), in cooperation with the UNHCR Office of the Chief of Mission, conducted a one-day session with the National Commission for Refugees and Department of Citizenship, Asylum and Migration (DCAM) to strengthen cooperation and address challenges faced with decision-making instances when assessing asylum claims. The legal framework gaps were analysed and specific legal cases were reviewed to strengthen the efficiency of the legal protection institutions during refugee status determination procedures.

UN-Habitat Kosovo finalised the concept for a new social housing programme, which will promote access to housing for the poor, neighbor-hoodbased interventions for inclu-sive green interventions, and energy efficient home improvements across Kosovo The programme is being devel-oped in coordination with the Office of the Prime Minister, and with the Ministry of Environment, Spatial Planning and Infrastructure, Ministry of Finance, Labour and Transfers, and the Parliamentary Committee Dealing with Environment and Spatial Planning, and with funding from the Council of Europe Develop-ment Bank. It is expected to commence later in 2022.

Anti-Corruption Day

Through the project, "Support to Anti-Corruption Efforts in Kosovo (SAEK)", UNDP marked International Anti-Corruption Day with a series of activities, including the launch of the "Report on Gender and Corruption Related Vulnerabilities in the Public and Private Sector" and three animated, awareness-raising videos. The report presents findings on corruption risks and vulnerabilities at both central and local levels, with a focus on gender-based differences. The data reveals the differing insights and experiences of women and men and the importance of understanding if the perceptions of, exposure to, and impact of corruption differ by gender.

Integrated Cultural Heritage Conservation for Green, Inclusive Sustainable Development

UN-Habitat and the Ministry of Culture, Youth and Sports, launched a project through the Inclusive Development Programme, funded by the Government of Sweden, for the integration of cultural heritage for green, inclusive, sustainable development in municipalities, notably Pristina, Prizren and South Mitrovica. Rapid development in urban and rural areas and uncontrolled construction are key challenges faced by historic zones and centres. The integration of cultural heritage into spatial planning processes and investments is necessary to address these challenges. The Ministry of Environment, Spatial Planning and Infrastructure will also be engaged.

Training for Forestry Legislation Implementing Authorities Continues

FAO provided training to legal officers of the Ministry of Agriculture, Forestry and Rural Development (MAFRD), officials of the Kosovo Forest Agency, forestry inspectors, judges, prosecutors, police officers, and lawyers under the programme, "Support to strengthening sustainable and multipurpose forest management to improve rural livelihoods and address climate change in Kosovo", funded by the Swedish Embassy. Trained by a renowned judge from Kosovo, participants gained insight into the procedures and learned how to prepare documentation to file cases, denounce illegal forestry activities, calculate damages in line with legislation, and control logging contracts, licenses, and transport, trade and processing permits. The accountability of forestry inspectors, guards and other officials in cases of abuse was highlighted.

#WasteWiseKosovo Challenge Champions Announced As part of the #WasteWiseKosovo Challenge, US Embassy in Pristina and UN-Habitat, in partnership with BONE-VET, the Kosovo Innovation Center (ICK), Coca-Cola HBC, the American Corner and Kosovo United States Alumni (KUSA) invited creators, dreamers, designers and technology entrepreneurs and others interested in contributing to a healthier future in Kosovo, to present innovative ideas and solutions for waste reduction in Kosovo's cities and communities. Of the 56 business ideas presented, four were selected.

Official Visit of WHO's Dr Siddhartha Datta

The WHO Project manager for the Europe Region, responsible for the Vaccine preventable diseases and Immunization Programme, Dr Siddhartha Datta , conducted an official visit to Kosovo to support the coordination of activities. Licensing of Health Laboratories and Establishment of Reference Laboratories

The WHO Pristina Office, in collaboration with WHO HUB and WHO Office for Europe, organized a workshop on the licensing of health laboratories and the establishment of reference laboratories. Bringing together participants from MoH, IPH, Accreditation Directorate, UCCK and Private laboratories, the workshop aimed to identify accreditation mechanisms and procedures for human laboratories as well as gaps and the means to address them.

UNICEF Supports MoH in Promoting the COVID-19 Vaccine

UNICEF, in partnership with USAID, supported MoH in promoting COVID-19 vaccinations. Advocacy and visibility materials were produced and doctors were mobilised to educate the public on the importance of being vaccinated to help reduce risks related to the pandemic.

Inception Workshop of the "Knowledge for Reform Action in the Western Balkans" Project

UNOPS Austria Multi Country Office, in cooperation with the Norwegian Embassy in Pristina and the Office of the Deputy Prime Minister for European Integration, Development and Dialogue, hosted the first workshop for the "Knowledge for Reform Action in the Western Balkans" project. Representatives of the Prime Minister's office, relevant ministries and the EU Kosovo identified priority areas of intervention and established grounds for future cooperation. With funding from the Norwegian Ministry of Foreign Affairs, UNOPS will deploy experts in the next five years to support government institutions across the Western Balkans in their policy reform processes through capacity development and knowledgesharing.
